Subject: Freedom of Information (Scotland) Act 2002 – Release of Information Request: Reports/Complaints of Damp and Mould (2019–2024)

Thank you for your request dated 27 May 2025, submitted under the Freedom of Information (Scotland) Act 2002. You asked for:

"The number of reports or complaints received by the housing association relating to damp and/or mould in tenant properties, broken down by year, for each of the last five calendar years (2019–2024)."

We have now considered your request and are pleased to provide the following information.

Information Provided

Due to an upgrade of our Customer Relationship Management (CRM) system, we are only able to provide data from 2022 onwards. Records from 2019 to 2021 are stored within our previous CRM system. Accessing this older data would require system reactivation and manual retrieval, which may incur a cost. Should you wish to proceed, we would be happy to provide an estimate.

Mould-Related Reports

- 2022:17 cases reported
- 2023:46 cases reported
- 2024:54 cases reported

Please note that no formal complaints specifically relating to damp or mould were recorded during this period.
